On June 6, 2024, I Officer Melvin, #4376 was dispatched to 4641 W. Eau Gallie BL. (Raceway Gas Station) for the report of an armed disturbance in progress.

Upon arrival I met with Jorge Cardoza (Victim) and Bryan Cardoza (Victim) who stated they were attacked by two males with a knife.

Bryan Cardoza stated his brother Jorge had been on Facebook marketplace finding him a fish tank to buy. Bryan said Jorge told him he had a guy that would meet them at the Raceway with the fish tank. Bryan said he and Jorge went to the gas station and were waiting on the person with the fish tank when a large black Dodge pick-up pulled into the parking lot. Bryan said Jorge told him to stay in the car because he knew the guys in the truck, and they were there to fight. Bryan said Jorge yelled out to the males in the truck and asked, "are you here to fight or sell a fish tank". Bryan stated one of the males jumped out of the truck and started coming at them and Jorge told him to drive away.

Bryan said he drove around the parking lot multiple times to get away from the males in the truck that were chasing them. Bryan said at one point the males in the truck were able to cut them off and one of the passengers jumped out of the truck ran at the car with a large hunting style knife in his hand and hit the driver's door window and hood of the car with the knife. said he was scared, and he quickly reversed and while trying to get away from the male with the knife he backed into one of the gas pump stations knocking it over and causing damage to the property.

Bryan said he believed the male driving the truck was trying to ram them and the male with the knife were trying to hurt him and his brother Jorge and that's why he was driving all around the parking lot and what caused him to run into the gas pump.

Jorge Cardoza stated he had been using his mother's Facebook to locate a fish tank to buy for his brother Bryan. Jorge said he found a guy that had a picture of a dog as his profile picture but no name that had a fish tank and was willing to meet them. Jorge said once they were at the Raceway he realized the person he had been talking to was Charles Conner (Arrestee) who he has a long history with. Jorge said he told his brother to stay in the car because they were there to fight him. Jorge said he yelled out to Charles "are you here to fight or sell the fish tank". Jorge said at that time two males got out of the truck, one being Charles Conner and the other was Michael Duff (Arrestee). Jorge said he got back into the car and told his brother to drive. Jorge said Charles and Michael got back into the truck and chased them around the parking lot until they were able to cut them off and block their path. Jorge said Michael jumped out of the truck with a large hunting style knife and ran up to the car and began to bang on the hood of the car and then the driver's side door window. Jorge said his rother was scared and quickly reversed the vehicle and crashed into the gas pump causing it to be knocked over. Jorge said Charles and Michael got back into the truck and sped off.

Charles Conner and Michael Duff were located a short time later at 1323 Ashwood Dr. Both Michael and Charles were placed under arrest at this location and transported to the Melbourne Police Department for booking. Both Charles and Michael were advised of their

### Miranda Rights.

When questioning Charles Conner, he stated he had been talking with who he believed to be a female named "Emilia" about buying his fish tank. After two days of conversation "Emilia" told him she wanted to purchase the fish tank and she would meet him at the RaceTrac gas station on SR-192. Charles said he and Michael went to the agreed-upon location and no one was there. Charles said he messaged "Emilia" back and she gave him another location that had the same results. Charles said he messaged her back again and said send him a picture of where she was, and he received a picture of the Raceway Gas Station of Eau Gallie Bl. Charles said they arrived at the Raceway and seen Jorge in the parking lot. Charles said he yelled at Jorge and asked him "why was he setting him up". Charles said Jorge said he had a gun and reached into his shorts like he was going for the gun. Charles said he and Michael went towards Jorge and he jumped back into the car and started driving around the parking lot. Charles said Jorge signaled to him to follow them, so he thought that's what they were doing but the car just kept circling the parking lot. Charles said he was able to finally cut off Jorge and Bryan and that's when Michael jumped out of the truck with the knife and banged it on the hood and window. Charles said at the point Bryan reversed the car into one of the gas pumps and he and Michael left the area.

Michael Duff said when he went to the car with Jorge and Bryan in it, he had no intention of hurting them, but he wanted to be able to defend himself if Jorge did have a gun. Michael said he used the end of the handle to bang on the window and the hood.

Both Charles Conner and Michael Duff were transported to the Brevard County Jail and turned over to jail staff.
